

## Genocide 60 Years after the Convention

Brighton, England, 4<sup>th</sup> and 5<sup>th</sup> December 2008

On 9<sup>th</sup> December 1948, the United Nations General Assembly adopted the Convention on the Prevention and Punishment of the Crime of Genocide. It had taken less than five years since Raphael Lemkin first published his idea of 'genocide' for it to become defined as a supreme international crime, in one of the most potent legal and political documents of the post-war international order. Yet sixty years later, genocide has recurred on the international agenda from Cambodia to Bosnia and Rwanda to Darfur, and international political and legal action to 'prevent and punish' it remains very limited.

However, two types of development could be considered more hopeful: *legal developments*, in the first international prosecutions for genocide by the Yugoslav and Rwandan tribunals and the incorporation of genocide law into the statutes of the new International Criminal Court and *wider academic developments*, which have seen scholars in history, sociology, anthropology and international relations, as well as law, develop increasingly wide-ranging scholarship in the new interdisciplinary field of 'genocide studies', which has given us many new insights into historical and contemporary genocidal violence.

On the 60<sup>th</sup> anniversary of the Convention, this symposium will, therefore, address issues surrounding three main questions of the current genocide studies agenda:

- How have genocide and the patterns of its occurrence developed over the last 60 years?
- How adequate has the Convention proved, and how has international law responded to new challenges of genocidal practice?
- How adequate has the historiography and social science of genocide been in responding to the challenges of understanding genocide?
